

Notice under the Americans with Disabilities Act

In accordance with the requirements of title II of the Americans with Disabilities Act of 1990 (ADA), the Hudson River – Black River Regulating District will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs or activities.

Employment: The Hudson River - Black River Regulating District does not discriminate on the basis of disability in its hiring or employment practices and complies with all regulations promulgated by the U.S. Equal Employment Opportunity Commission under title 1 of the ADA.

Effective Communication: The Hudson River - Black River Regulating District will generally, upon request, provide appropriate aids and services leading to effective communication for qualified persons with disabilities so they can participate equally in the Regulating District's programs, services and activities, including qualified sign language interpreters, documents in Braille and other ways of making information and communications accessible to people who have speech, hearing or vision impairments.

Modifications to Policies and Procedures: The Hudson River - Black River Regulating District will make all reasonable modifications to policies and programs to ensure that people with disabilities have an equal opportunity to enjoy all of its programs, services and activities. For example, individuals with service animals are welcomed in Regulating District offices, even where pets are generally prohibited.

Anyone who requires an auxiliary aid or service for effective communication, or a modification of policies or procedures to participate in a program, service or activity of the Hudson River – Black River Regulating District, should contact the Hudson River Area Office, John C. Callaghan, at (518) 465-3491 or by email at HRAO@hrbrdd.ny.gov as soon as possible but no later than 48 hours before the scheduled event.

The ADA does not require the Hudson River - Black River Regulating District to take any action that would fundamentally alter the nature of its program or services or impose an undue financial or administrative burden.

Complaints that a program, service or activity of the Hudson River - Black River Regulating District is not accessible to persons with disabilities should be directed to John C. Callaghan at (518) 465-3491 or by email at HRAO@hrbrdd.ny.gov.

The Hudson River - Black River Regulating District will not place a surcharge on a particular individual with a disability or any group of individuals with disabilities to cover the cost of providing auxiliary aids/services or reasonable modifications of policy, such as retrieving items from locations that are open to the public but are not accessible to persons who use wheelchairs.
