**RESOLUTION TO AWARD AUDIT SERVICES WORK TO
GALLEROS ROBINSON CERTIFIED PUBLIC ACCOUNTANTS, LLP
FOR FISCAL YEAR ENDING JUNE 30, 2022**

WHEREAS, the Board approved resolution 19-25-05 awarding audit services to Galleros Robinson Certified Public Accountants, LLP (Galleros Robinson), an MBE/WBE firm, for fiscal year July 1, 2018 through June 30, 2019; and

WHEREAS, resolution 19-25-05 authorized the Regulating District to extend the audit services engagement for one additional year, which it did by adopting resolution 20-16-05; and

WHEREAS, the Board approved resolution 21-15-04 awarding audit services to Galleros Robinson Certified Public Accountants, LLP for fiscal year July 1, 2020 through June 30, 2021; and

WHEREAS, Galleros Robinson has ably provided audit services for fiscal years July 1, 2018 through June 30, 2019, July 1, 2019 through June 30, 2020 and July 1, 2020-June 30, 2021; and

WHEREAS, the Hudson River-Black River Regulating District believes it is in the best interest of the Regulating District to engage a MWBE qualified firm; and


WHEREAS, Nora Galleros, Partner in Charge at Galleros Robinson, has agreed to continue performing the Regulating District's audits; and

WHEREAS, Galleros Robinson has agreed to provide independent audit services to the Regulating District for the fiscal year July 1, 2021 through June 30, 2022; and

NOW THEREFORE BE IT RESOLVED, the Board of the Hudson River-Black River Regulating District hereby awards audit services work for the fiscal year July 1, 2021 through June 30, 2022, to Galleros Robinson; and

BE IT FURTHER RESOLVED, the Board of the Hudson River-Black River Regulating District hereby authorizes the Executive Director to exercise the first one-year option included in contract C012021 for the amount of \$25,925.00, plus expenses up to \$1,200.00 (if needed) for the audit of fiscal year July 1, 2021 through June 30, 2022.
